



NSC Coyote Creek Trail Bike Ride Oct 3



Join us for a scenic, flat ride starting in San Jose at the Coyote Creek multi-use trail following the longest creek in Santa Clara County as it flows from Anderson Dam to Hellyer Park. Along the way we'll past Coyote Ranch, a historic ranch surrounded by palm and giant pepper trees. Further on, the trail passes the Santa Clara County Model Airplane Skypark, where (if we're lucky) we'll see an air show of fast, agile planes doing showy aerobatics. After passing under Hwy 101, we cross Coyote Creek on a wide bridge, run through an old orchard, and end in the middle of a subdivision. From there, we'll follow city streets to the Anderson Lake County Pk. where we stop for lunch. In the afternoon, we return the same way to Hellyer Park for a round trip of about 32.5 miles.
