Sun Valley, <http://www.sunvalley.com>, has 2054 acres, 3,400 feet vertical, 9,150 feet summit elevation. The lodge is at 5920 feet above sea level. Sun Valley also has Heli-Skiing.

We will be staying at the Sun Valley Standard Condos which forms a horseshoe around the village and is within a ten-minute walk of the Sun Valley Inn or Lodge.

CANCELLATION POLICY

Traveler is responsible for finding a replacement. Any refund of traveler's payments will be contingent on applicable fees charged to the Nisei Ski Club by the travel agent.

LAND ONLY

If you want to book your own air, you can take the Land Only package for \$890. We have paid for a charter bus to take all of us from BOI to Sun Valley. Your Land Only package includes this bus. If your flight misses this bus, then you are responsible for your own transportation from the airport to Sun Valley.

Our last group flight arrives at BOI on Jan 21, 2012, 1:36pm. Our first departing flight from BOI is on Jan 28, 2012, 12:35pm. If you purchase a Land Only package and you want to catch NSC's chartered bus, you must arrive at BOI no later than the last club booked flight which is scheduled to arrive at 1:36 pm on Jan. 21, 2012.

If you are booking your own flight, you may want to fly directly into SUN instead of BOI. SUN (Hailey's Friedman Memorial Airport) is only 14 miles from Sun Valley, but flights are limited.

PURCHASE MONEY HELD IN SEPARATE (TRUST) ACCOUNT

California law requires certain sellers of travel to have a separate (trust) account. The NSC has such an account. Traveler's purchase payment(s) will be held in this account until used to pay applicable trip fees and expenses.

TCRF PARTICIPATION

The Nisei Ski Club is a participant in the California Travel Consumer Restitution Fund (TCRF). Eligible California travelers may file a claim with TCRF if the traveler is owed a refund of more than \$50 for transportation or travel services which the seller of travel failed to forward to a proper provider or such money was not refunded to you when required per the stated cancellation policy. The maximum amount which may be paid by the TCRF to any one traveler is the total amount paid on behalf of the traveler to the seller of travel, not to exceed \$15,000. A claim must be submitted to the TCRF within 12 months after the scheduled completion date of the travel. A claim must include sufficient documentation to prove your claim and a \$35 processing fee. Claimants must agree to waive their right to other civil remedies against a registered participating seller of travel for matters arising out of a sale for which you file a TCRF claim.
