

# NSC 2017 Ski Week Trip to Snowmass, CO

Mountain Collective season passes are good for two days at Aspen Snowmass and a third resort of your choice.

We are flying into Aspen Airport, which includes shuttle bus service to the Crestwood Condominiums. Your Land-Only package includes this shuttle bus.

Our flight (United 5199) arrives in Aspen Airport on Saturday, 28 January at 11:45am and our shuttle bus will leave shortly thereafter.

- If your flight arrives Aspen Airport at a **later or earlier** time then you can call for the Crestwood shuttle bus.

Our return flight (United 5906) departs Aspen Airport on Saturday, 4 February, at 1:55pm. Departure time from the Crestwood condos will be in the morning before noon.
