

NSC 2026 Ski Week Trip to Park City/Canyons, UT



Jake the Ski Fool says “follow me to Park City/Canyons for our 2026 ski week trip.” Park City has combined with The Canyons to bring you over 7300 acres of skiing. NSC has not been to Park City since 2016 and it’s time to make a return trip.

Dates: 7 – 14 February 2026
Price: \$2160 (No Senior Rates)

Trip price includes:

- Roundtrip airfare from San Francisco to Salt Lake City on Alaska Airlines
- Roundtrip charter bus from Salt Lake City to Park City
- 7 nights stay at the Snow Flower Condominiums
- Lift tickets must be purchased separately
- Farewell Dinner
- Mid-week activities at additional cost:
 - Flying Eagle Zip Line
 - Alpine Coaster
 - Sleigh Ride and Dinner
 - Viking Yurt
- Price **does not** include Baggage Fees

REAL-ID or Passport Required

The deadline to obtain a REAL ID was May 7, 2025. After this date, you will need a REAL ID-compliant driver’s license or another federally accepted form of ID (Passport) to board domestic flights.

Price and availability guaranteed for 36 air seats only, 44 total for lodging. Sign up now and avoid the rush. (See Trip Application form).

Sign-up deadline: October 20, 2025. Please submit the Application and Package Options pages.

Rooming: Condos are 2BD/2BA (11 units). Accommodations will be assigned based on roommate preference and room availability.

Cancellation Policy: It is your responsibility to find a replacement if you cancel. Cancellation fees will depend on what NSC is charged and what is refunded from Alaska Airlines, or the Snow Flower Condominiums.

You must be at least 21 years of age and a member of the Nisei Ski Club to sign up for this trip.

Land Only Package

If you want to book your own air then select the **Land-Only Credit (Line Item A)**.

We are flying into Salt Lake City, which includes our own charter bus from Salt Lake City to Park City and is about a 45-minute drive. Your Land-Only package includes this charter bus.

The Alaska AS3456 flight arrives in Salt Lake City on Saturday, 7 February, at 11:41am and our charter bus will leave shortly thereafter.

- If your flight arrives Salt Lake City at a **later** time then you will be responsible for arranging your own transportation to Park City Snow Flower Condos.
- If your flight arrives Salt Lake City at an **earlier** time then you can take the charter bus with the rest of the group.

Our return flight (AS3456) departs Salt Lake City on Saturday, 14 February, at 12:21pm. Departure time from the Snow Flower condos will be ~9:30am.

Lift Tickets

Lift tickets **are not** part of the package and you must purchase your own tickets. Here are several options:

- Epic Pass (\$1051) – Unlimited skiing at Park City and other resorts.
- Epic Local Pass (\$783) – Unlimited skiing at Park City with blackout dates (blackout dates do not affect this trip).
- Epic Tahoe Local Pass (\$665) – 5-days total at Park City with blackout dates (blackout dates do not affect this trip), and unlimited, 7 days a week at Heavenly, Northstar, and Kirkwood (with blackout dates).
- Epic 5-day adult pass, holidays excluded (\$527)
- Epic Passes purchased through Sports America will provide a rebate of 6.5% of your purchase price and if you go on the Park City ski trip. <https://www.sportsamerica.com/epic-nisei>

TSA Notes

TSA Pre-Check is very popular with frequent flyers and offers shorter lines at the security gate. If you have a Known Traveler Number (KTN) then be sure to enter it on the application form.
